4. Consider Recommendation of the Reallocation of Dedicated Reserve Funds

Interim District Manager Farned provided a presentation on the item. Trustee Capoccia inquired if there should be policy that specifies required reserve amounts and about using capital reserves for this purpose. Interim District Manager Farned indicated that a policy is not necessary at this time and stated that capital reserve amounts were available to use for discretionary payments due to unfeasibility of a new district building which reserves were initially set for. Motion by Trustee Leon, seconded by Trustee Capoccia, and carried by the following vote to recommend the reallocation of dedicated reserve funds as proposed.
